Minutes from the SEDOM Executive Board Meeting March 15, 2023

The meeting of the SEDOM Executive Board was convened in person at 8:22am on Wednesday, March 15, 2023.

The meeting was called to order at 8:22am.

Recognition and Identification of Visitors and Public Comment: No official visitors were noted

**Freedom of Information Act Requests**: An annual request from the Illinois Retired Teachers Association was discussed.

**Communications**: Dr. Burns referenced a letter submitted by Ms. Diana Hartmann of the Regional Office of Education which terminated the agreement for fiscal agent services between SEDOM and the ROE-RSSP.

## **Closed Session**
