Minutes from the Special Meeting of the SEDOM Governing Board of Directors March 6, 2024

A meeting of the Governing Board of Directors of the Special Education District of McHenry County convened at 7:00pm on Wednesday, March 6, 2024, at the SEDOM Educational Center, 1200 Claussen Drive, Woodstock, IL.

Call to Order: Ms. Lea Damisch, President of the Executive Board, called the meeting to order at 7:00pm.

Seven of the eleven-member districts were present at roll call.

Introduction of Executive Board and Administrative Staff:

Following roll call, Dr. Damisch introduced the Executive Board members present who were also concurrent members of the Governing Board of Directors including Mr. Bryan Millard, Ms. Cathy Neiss and Ms. Karen Parks. Dr. Damisch also introduced Executive Board Member Dr. Corey Tafoya. Also present was the Executive Director, Dr. Tim Burns.

Approval of August 2, 2023, Governing Board Meeting Minutes:

District 18 moved; District 12 seconded the approval of the minutes of the August 2, 2023, meeting of the Governing Board of Directors. On a voice vote the motion passed unanimously.

Appointment of Executive Board Members:

Dr. Burns noted that per the Articles of Joint Agreement that all terms of office were fulfilled and that the terms of four Executive Board Members would be completed in 2025, and that no further action was required until then.

Designation of the August Governing Board of Directors Meeting:

District 50 moved, and District 36 seconded that the Governing Board Meeting in August which primarily focuses on the budget be held on Wednesday August 7, 2024. On a voice vote the motion passed unanimously.

Executive Director's Report: Dr. Burns gave an update on the current financial status of SEDOM and the move toward a reduced operating cost being proposed for FY 25. Dr. Burns also discussed the current ten-year rental agreement with an option to purchase the property that it entered into with the MENTA Group. Dr. Burns discussed the long-range financial plan that could involve officially moving SEDOM's operations in to its classroom in H158. Dr. Burns discussed the reduction of days for audiology and discussed several scenarios associated with the future location of the audiology program. Dr. Burns discussed that the current financial model is dependent upon Evidenced Based Funding and rental income. Dr. Burns mentioned that the Evidence Based Funding dollars were used to primarily subsidize the audiological program.

Dr. Burns then discussed cooperative models and that the SEDOM member districts have placed a value in preserving the functional viability of the cooperative with a more limited and reduced footprint in favor of the member districts maintaining greater local control and autonomy in decision making. Dr. Burns mentioned that all districts expressed a desire for SEDOM to continue operations and maintain the ability to expand based upon future needs. Dr. Burns then discussed portions of the FY 25 Needs Assessment.

Other Business: No other business.

Adjournment:

District 36 moved; District 15 seconded to adjourn the meeting at 7:46pm. On a voice vote, the motion

The Articles of Joint Agreement specify that it is the duty of the Governing Board of Directors to adopt the annual budget of SEDOM.

Following the hearing, the Governing Board considers adoption of the FY25 budget.

Subject: Appointment of Nominating Committee

ARTICLE 2- ORGANIZATION AND OPERATION of the Articles of Joint Agreement provide the following specifications for the make-up and election of the Executive Board.

Section 2: Executive Board of Directors. From the members of the SEDOM Governing Board of Directors, from the members of the participating district boards of education, or from the Superintendents of Schools of the member districts, there shall be chosen an Executive Board consisting of seven (7) members, at least two (2) of these from high school or unit districts, at least two (2) of these from elementary school districts, and at least one (1) board of education member. Except as set forth below, the Executive Board members shall serve a four (4) year term. The election for Executive Board members shall take place at the meeting of the Governing Board of Directors held during the third or fourth quarter of the school year, and those elected shall take office at the first regular meeting of the Executive Board after July 1st.

- A. When a vacancy occurs on the Executive Board the remaining members shall fill the vacancy by appointment until the next regular election at which time a person will be elected to fill the unexpired term.
- B. Not later than thirty (30) days prior to the Governing Board of Directors meeting held during the third or fourth quarter of the school year the President of the Executive Board shall appoint a committee of two members of the Governing Board of Directors not serving on the Executive Board to submit a list of candidates to serve on the Executive Board. This list will be submitted to the member districts thirty days prior to the third or fourth quarter meeting of the Governing Board of Directors.
- C. Following the installation of the new members at the first regularly scheduled meeting of the Executive Board in July, a President, Vice President and Secretary shall be elected by the Executive Board members.

Volunteers to serve on the Nominating Committee for the March Executive Board election are sought at this meeting.
